A) Hedge at corner of holyrood place-

A local resident raised an issue about the hedge which is on the puregym corner- when crossing the road it is very hard to see any oncoming cars, as this land isn't owned by FC they can not help, however an email has been sent to the insurance company who own the land.

B) potential crossing on pilmuir street. A local resident also raised a concern about the lack of crossing on pilmuir street. This was discussed that as pilmuir street has a multiple bus stops to close to junctions etc- it is very hard to add in another crossing.

C) Mini roundabout at hill street and campbell street- a local resident raised the concern that we havnt heard a lot about the hill street roundabout which was proposed to the FC last year. Cllr Gordon Pryde is going to follow this up.

D) A&E petition the CC had discussed that there was many petitions started and none were seen valuable to scottish government or NHS Fife. Unfortunately this is outwith our control about the petition a local resident started and even though we had signatures, NHS Fife is reluctant to bring back an A&E at the QMH.
