April 2024 marked a significant transition for Headwell Community Council, as we officially took over the responsibilities of the CC. At the time, the CC consisted of just six members. Since then, we have made considerable progress:

- We updated our official contact details, including changing the council's email address.
- Membership has grown steadily, and we are pleased to report we now have 11 members—nearing full capacity.
- In late April, we began exploring the potential for local park and garden projects. We are proud to announce that both initiatives have been successfully completed. While the garden remains an ongoing area of attention, significant improvements have already been made.

Community Engagement

- **Community Meetings:** We have hosted several open meetings to discuss local concerns, gather community feedback, and collaboratively shape our priorities.
- **Volunteer Opportunities:** Residents were encouraged to get involved in local events and volunteer-driven projects, fostering a greater sense of community and ownership.
- **Coffee Morning:** we started a coffee morning for about a year and was good but not enough local residents got involved.

Infrastructure and Environment

- **Play Park Development:** Plans were announced for the creation of a new play park to provide a safe and engaging space for children and families.

Community Safety

- **Crime Prevention:** In response to concerns about drug-related activities, we have urged residents to report incidents to the police or via Crimestoppers to ensure swift action.
- **Anti-Social Behaviour:** Joint patrols with local authorities were organized to deter anti-social behaviour and provide a visible presence to reassure the community.

Looking Ahead

As we move forward, Headwell Community Council remains committed to:

- **Enhancing Safety:** We will continue implementing strategies to reduce crime and anti-social behaviour within our community.
- **Building Engagement:** Increasing community participation in decision-making processes and encouraging active involvement in local events and projects.
